EAGLE'S NEST GANG IN SHOOTING SCRAPE

Tom Riley Shoots Member of His Own Band On Streets of Columbia Falls---Makes Effort To Get Away But Is Run Down After Reaching Railroad.

Tom Riley and Harry Shafter are in the county jail here, held in connection with the killing of Frank Murphy, who was shot at Columbia Falls yesterday by Riley with a gun borrowed by Shafter from Theodore Christenson's jewelry store, in Columbia Falls.

The provocation of the shooting remains a mystery. The details of the crime are reported as follows: The men in fail and the man killed are all said to be members of a robbers' roost gang holding out at a place above Columbia Falls known as Eagle's Nest. Riley and Shaffer were walking along the street when Shaffer entered the Christenson jewelry store and borrowed the rifle, taking it out and handing it to Riley, who pointed it at Murphy who had just turned the corner at a small grocery store just ahead of them. Murphy raised one hand above his head and put the other in his pocket, grasping an open jackknife, when Riley fired, the bullet striking Murphy in the neck, killing him almost instantly.

Riley ran into a store building and out the back way up the alley, going toward the Great Northern depot. A party in an automobile consisting of Town Marshal Jacob Neitzling, Herman C. Selvage and Dr. J. T. Robinson started in pursuit, overtaking him at the depot. Riley ran-across the right-of-way and hid in the brush on the other side. Marshal Neitzling called to him to give up but Riley refused and the marshal fired a shot at him, grazing his clothes. Riley, probably thinking that was close enough, called to Neitzling that he would give up if he would not shoot again. Riley was placed in the town jail at Columbia Falls along with Shaffer, who was caught in the meantime, and Sheriff Ingraham was notified at Kalispell to come after them. They were brought down on the night train.

Sheriff Ingraham and Coroner Waggener are in Columbia Falls today holding the inquest.

EUREKA FARMER KILLED HIMSELF

Eureka, Oct. 13—P. J. Scum, a prosperous farmer residing six miles from Eureka, killed himself yesterday afternoon with a thirty-two rific. He had been acting strangely for some time, several times threatening suicide. He would often absent himself from his home without apparent reason. Formerly he was a heavy drinker and the despondency resulting is supposed to have affected his mind. He leaves a large family.
