Mary Allison Patton was born near Whitesburg, Pa., (Armstrong County), Aug. 14, 1872, and died May 16, 1924.

She was educated in the public schools in the county where she was born.

In the spring of 1901 she with her sister, Nancy, came to the Flathead on a visit to their sister, Mrs. Walter Jaquette. In October, 1902, she made the trip back to Pennsylvania, but after a few weeks returned to Kalispell where she remained until 1904, when both sisters were called east on the death of their father. Mary remained there, taking care of her mother until the spring of 1909, when she came into the deceased sister's home, to care for the infant James, who most of all needed a mother's care.

August 3, 1910, she was married to Mr. Walter P. Jaquette at the home of Mr. and Mrs. J. P. Blose, by Rev. George. McVey Fisher.

Her death has stilled forever the kindest voice, the most willing of helpful hands and one of the most thoughtful spirits on earth. Her life has been one waged against the tides but always borne with amazing strength and courage.

He has been a faithful pastor to the church that he loved and a tireless worker for the building of the Kingdom of the Lord whom he served. In the midst of a series of special meetings he was taken seriously ill and several weeks ago abscesses formed in his throat and head. KALISPELL PAYS TRIBUTE TO REV. E. F. JUDSON

A large number of people from all walks of life and representative of all the interests of the community met Sunday, Feb. 17th to pay their farewell tribute to the Rev. Eugene F. Judson, pastor of the First Baptist church of Kalispell. Dr. Cress, State Secretary of the Baptist church and a former classmate of Rev. Judson, paid a splendid tribute to his old time friend and comrade. His text was taken from I John 5:4, "This is the victory that overcometh the world, even our faith." He said that the evidence of a man's faith is not in what a man says but in what he is and does. And it seemed to those who knew Rev. Judson best that he was a true example of that faith, by his love for his fellow men, his patience toward life's tasks, his kindness in dealing with others and in the spirit of meekness which he always manifested.

The high esteem in which Reverend Judson was held in the community was exemplified by the presence on the platform of the pastors of the various churches of the city. Rev. Walter B. Spaulding of the Methodist church read the scripture lesson and paid a brief tribute to the heroic faith with which Brother Judson faced both life and death. Dr. B. Scott Bates, of the Presbyterian church spoke of his splendid spirit of co-operation. Rev. Edward Parker of the Christian church offered the prayer. The music was furnished by the Westminster Quartet of the Presbyterian church. Interment was made in the Conrad cemetery by the side of "Buddy" MacDonald, whom he had laid to rest only a few months previous.

Eugene F. Judson was born in Nora Springs, Iowa on August 12th, 1871. He took his academic course in the Baptist Academy at Sioux Falls, So. Dak., and his college degree at Yankton college, Yankton, So. Dakota. His theological course was taken at the University of Chicago. In 1903 he was united in mar-

CHARLES W. JUNGBERG DIES AFTER LONG ILLNESS

Charles W. Jungberg formerly Montana State forester and well known throughout the valley for the past 25 years, died at his home on Fourth avenue east last evening after a lingering illness, at the age of 63 years.

Mr. Jungberg came to the Flathead nearly a quarter century ago and for many years was in charge of logging operations for the John O'Brien Lumber company and later after the purchase of the O'Brien interests by the Great Northern railroad, he occupied a like capacity with the successor firm which became the Somers Lumber company about 16 years ago.

He remained with this concern until his appointment as state forester when he moved to Helena where he lived during his term of office.

After his return to the Flathead he continued in the same business, for a time with the Somers Lumber company and for some time in the employ of the state and of various private timber interests.

Funeral services will be held Thursday afternoon at 2:30 at the Masonic temple under the auspices of the Masonic lodge and the Knights Templar, and interment will be made in the Conrad cemetery under the direction of Waggner & Cambell.
