THINK DAHLBERG WAS DEAD BEFORE CRASH

O. F. Vose has returned from Enreka where he yesterday attended the funeral of F. J. Dahlberg, and also that of Asa N. Douglas, a relative of Mr. Vose's.

He states that the Dahlberg funeral was conducted under the auspices of the Masonic lodge, and was very largely attended. The body was shipped east for burial.

Speaking of the accident which it is believed caused Mr. Dahlberg's death, Mr. Vose says a fireman on train 227 makes the statement that as his train rounded a curve some distance away he saw a car standing on or near the track. He was not alarmed as he thought the car had either stopped on one side of the crossing or had ample time to cross the track. The train then passed through a small cut so that the car was not visible, and then the crash came. It is said that Mr. Dahlberg suffered from heart trouble, and it is thought that possibly he may have been dead in the car when it was struck. He had made his will three days before the accident, and at the time remarked to his attorney, H. G. Pomeroy that "maybe the crossing would get him." It is said that he was always worried about the danger of the crossing, and often warned his men to be very careful at that point.

MANNING C. DALEY OF COLUMBIA FALLS DEAD

Manning C. Daley the 15 year old son of Mr. and Mrs. Chas M. Daley of Columbia Falls passed away at an early hour this morning. He has been an invalid since the age of 2 years.
