In the death of Mr. Fleek the community loses a well known, popular and highly respected citizen. Mr. and Mrs. Fleek removed to Libby in 1910 from Kalispell and have lived here since that time. Mr. Fleek engaged in the hardware business with his son Reuben under the firm name of Fleek & Fleek and conducted that business up to 1916 when it was consolidated with the Kootenai Mercantile company, of which he has been president of the board of directors. He was also one of the directors of the First National Bank of Libby.—Western News.

From her childhood on, deceased was of a happy, sunny disposition and by her kindly, helpful ways won the friendship and esteem of all with whom she came in contact.
