

**SERVICES FOR JOHN DAY
HELD AT SOLDIERS' HOME**

Funeral services for John Day, Civil War veteran, were held Monday afternoon at the Soldiers' Home, with the chaplain officiating. Interment was made in the Home cemetery.

John Day was born in Illinois in 1843. His mother was Mary Brown Day, a sister of the noted John Brown of pre-Civil War days, and

his father was Daniel Day, whose sister was John Brown's wife.

His mother passing away in Illinois, when he was about two years of age the family moved to Wisconsin, and later to Minnesota. Here the father also died. Five brothers and a sister, besides his parents, preceded him in death.

When the Civil War began, Mr. Day enlisted in the first Minnesota volunteers and after serving his time out, he enlisted with the sixth Wisconsin, serving to the end of the war.

He is survived by his widow and four sons and a daughter, also 14 grandchildren and eight great-grandchildren.

Joshua C. Day was born in Lancaster, Grant county, Wisconsin September 14, 1850 and died at the home of his daughter, Mrs. Henry Harris, Tuesday evening, January 18, 1927, at the age of 76 years, 14 months, 4 days.

He was married to Margaret Ellen Fry April 1, 1877. To this union seven children were born. The family lived in Wisconsin until 1916, when they came west, locating at Chester, Montana, this place being Mr. Day's home until December 21, when he came to this city to spend the winter with his daughter. Shortly after arriving here he was taken ill with pneumonia. His son Thomas and daughter Ruby came at once, and assisted Mrs. Harris in caring for their father. Everything that loving hands could do was done for him and every wish granted. Mr. Day was a patient sufferer and kept up his spirits and tried to cheer his children unto the very end.

He leaves to mourn his death, his wife, two sons, Albert and Thomas, of Libby; four daughters, Mrs. Maggie Mercer of Dickenson, North Dakota; Mrs. Carrie Wienze of Granton, North Dakota; Mrs. Esther Harris of this city and Mrs. Thompson of Redding California. One daughter, Ida, preceded him in death; two sisters, Mrs. Emily Fink of Excelsior, Minn., and Mrs. Linda Harris of Wisconsin; 15 grandchildren and 3 great-grand children also survive him.

Left to mourn her death are five children, Elbert Dyer of Somers, Ray, Glen and Alice of Creston, and Carroll J. of Walla Walla, Washington; her mother, Mrs. I. F. Davis of Kalispell; three brothers W. L. Davis of Silverbow, Montana, M. I. of Manicke, Montana, Bert of Libby and a sister, Mrs. Fred Hughes of Fortana, California. There are also four grandchildren living at Camas.
