Pomeroy was held, not only in this community, but in the state, was evidenced yesterday be the huge throng which gathered for his funeral, and followed the body to its last resting place in Conradumental cemetery. Before the hour of the funeral had arrived the Waggener & Campbell chapel was filled to capacity, and many couldnot gain admittance.

The services were under thauspices of the Masonic lodge of which he had been a member fo nearly half a century. Grand Lodge services under the direction of Grane Master George W. Craven of Butte were conducted by Past Grane Master Sol Hepner of Helena, as sisted by Past Grand Master, Dr. W Marshall, of Missoula, Acting Senio: Warden; John Kane of Helena Grand Junior Warden; Luther T Hauberg of Helena, Grand Secretary; and Edwin Fredlund of Chinook, Grand Senior Steward. The culogy was given by Rev. W. F Kochler, Grand Chaplain. Kalispel Lodge A. F. & A. M. marched in a body, and Cyrene Commandery formed an escort. ### Obituary

Charles W. Pomeroy was born in Jackson county, Kansas, June 2, 1866, and died in Spokane, Washington, April 10, 1935.

He received his early education in the country schools of Jackson county, Kansas, attended Campbell college, Holton, Kansas, and graduated from the inw school of the Kansas State University at Lawrence in 1899, being admitted to the bar after graduation. Soon afterward he came west to the then Territory of Montana, locating at Great Falls. July 12, 1899, where he began the practice of law, which he continued until March, 1895, when he was appointed judge of the Eleventh Judicial district, which was comprised of the counties of Flathead and Teton, by Governor J. E. Richards. During his residence in Great Falls he was prominent in all civic affairs, and served as president of the Board of Education.

After his appointment to the judgeship he removed to Kalispell, where he has since made his home. At the end of two years of service as judge he resumed his law practice, forming a partnership with C. H. Foot. In 1905 this partnership was dissolved, and he entered private practice which he continued until 1921 when he was elected judge of the Eleventh Judicial district. He continued on the bench until 1933, when he was succeeded by Judge J. E. Rockwood., He then returned to private practice, in which he was very successful. He was appointed by the court as administrator of the estate of the late J. E. Lewis, and was engaged in settling up this large estate at the time of his death.

On June 18, 1899, he was married to Miss Estelle Granger of Phillipsburg, Kansas, and to them were born three daughters, Mabel, who died in infancy, Velma, who has a position in the State Relief office in Helena, and Alice, who has been employed as her father's secretary. Beside Mrs. Pomeroy and his two daughters, he is survived by two sisters, Mrs. Charles E. Lyall of LaJolla, California, and Mrs. Reamer Billiard of El Paso, Texas, and two brothers, Frank C. and John Pomeroy of Holton, Kansas.

He has been prominent in Masonic affairs since becoming a member of the Holton, Kansas, lodge in 1899. Since coming to Montana he has been affiliated with Cascade Lodge No. 34, and Kalispell Lodge A. F. & A. M., No. 42. He was elected Worshipful Master of Cascade lodge in 1894, and Grand Master in 1898. He received the Royal Arch Degree in Kalispell Chapter No. 13 in 1895, and was High Priest of the chapter from December, 1899 to July, 1901; was knighted in Cyrene Commandery in 1903, and was commander from

1910 to 1911; and Grand Commander in 1919-1920; received the Shrine Degree in Algeria Temple in 1914; became a member of St. Peter's Conclave in 1912, and was a Past Grand Patron of the Order of Eastern Star.

As a jurist he was considered one of the most able in the state, and was often called to sit on the supreme bench. Attorneys who have practiced in his court say that he was more familiar with the Montana codes than any other man in the state. He had a remarkable knowledge of the law, a keen and analytical mind, and was bold and fearless in his decisions.
