# Funeral For Sp. 4 T. D. Kelso Tuesday At 2

SP 4 Todd Duane Kelso, 22, was killed in Vietnam as a result of non-hostile action June 10, 1968. He was born Jan. 22, 1946 in Kalispell and moved with his parents to Sunburst in 1950. He received his schooling in Sunburst and graduated from Toole County High School. He then worked for the Northern Telephone Co. in Sunburst for a year and in 1965 started school at Northern Montana College in Havre, completing a year.

Aug. 29, 1966 he entered the service and received his training at Ft. Lewis, Wash., Ft. Ord, Calif., and Ft. Bragg, N.C., where he received special warfare schooling and graduated as a Green Beret in the Air Borne Division.

He went to Vietnam in Oct., 1967 and was killed as a result of driving a military vehicle which went out of control striking a utility pole.

He is survived by his parents Mr. and Mrs. Todd B. Kelso of Sunburst and one sister, Mrs. Raymond Fritz, Sunburst.

# Whitefish Boy Killed In Shooting Accident

WHITEFISH — Fifteen-year-old Danny Kennedy was instantly killed about 8:55 p.m. Tuesday, the victim of an accidental shooting. He was the son of Mrs. Duane Fredenberg, 525 Somers Ave., Whitefish.

Police were called from the T. L. Torkelson home a mile west of Whitefish on Highway 93 at the state park road junction, and an ambulance was also dispatched. The boy was pronounced dead on arrival at the Whitefish Memorial Hospital at 9:02 p.m.

Flathead County Deputy Coroner David O. Cutler says investigation is continuing into the death but the shooting is believed to be accidental and self-inflicted. Authorities were not able to closely question Steven R. Engfors, 15, 235 O'Brien Ave., only witness to the accident. Young Engfors was distraught and was treated for shock following the incident.

Cutler said, "At the moment we have a fairly disjointed story from Engfors and there are still

some factors which need to be cleared up more fully. Apparently the two boys were out grouse hunting and were returning home.

"As we gather it, Kennedy wanted to plink tin cans and Engfors did not. Engfors kept walking along Highway 93 ahead of Kennedy when he heard a shot.

He turned and saw Kennedy laying on the roadway. There was a car approaching. Engfors dragged Kennedy off the highway into the borrow pit and then ran to the Torkelson home to call for help. Both Torkelson and another neighbor also reported hearing the single shot," Cutler said.

He continued, "The empty shell was still in the chamber of the 20 gauge shotgun. The charge took Kennedy in the face with most of the pattern entering his brain and causing instant death. There were also powder burns on the boy's face indicating the close proximity of the muzzle to his head.

"Actually we do not have an eye witness to the incident. We feel that young Kennedy either

tripped or dropped his gun with the weapon hitting the roadway in such a manner that it caused the shotgun to discharge," Cutler added.

The body was taken to the Austin Chapel at Whitefish where funeral arrangements are pending.

The boy was born Oct. 19, 1952, at Shelby. He later moved to Zurich and Cut Bank where he attended schools until moving to Whitefish in 1966. He was a sophomore at Whitefish High School at the time of his death.

He was a member of the Boy Scouts of Cut Bank and the Methodist Youth Fellowship.

He is survived by his parents, Duane and Dorothy Fredenberg; four brothers, Joe, Michael, Greg and Bruce, and seven sisters, Donna, Elaine, Marlene, Cindy, Karla, Pamela and Janine all at the family home in Whitefish; his grandparents, Mrs. Josephine Kennedy of Cut Bank and Mr. and Mrs. Anton Nelson of Zurich.

Funeral arrangements will be announced by the Austin Funeral Home.

## Joseph Kennett Funeral Set Wednesday At 2

WHITEFISH — Funeral services for Joseph Kennett, 45, Flathead resident for the past three years have been set for 2 p.m. Wednesday at the Waggener and Campbell Funeral Home.

Kennett died about 5 p.m. Saturday at the Whitefish Memorial Hospital from a self-inflicted gunshot wound. Flathead County Deputy Coroner David O. Cutler said an inquest will not be necessary and that all needed investigation has already been completed by Whitefish police and the Flathead County sheriff's office.

Kennett is survived by a son, Noel, and daughter, Lynne, living at Sacramento, Calif.; his mother, Mrs. Buelah Kennett, Missoula; and two sisters, Mrs. Jack Neff, Hobbs, N.M., and Betty Kennett, Missoula.

Military services are planned in conjunction with the funeral.
