Wilson believes the death is from natural causes.

He was born May 21, 1950, in Whitefish, a son of Adolph and Bessie Pahrman. He had attended Whitefish schools and had been employed in logging work for Ray Brown at the time of his death.

He was preceded in death by his father in 1963, and is now survived by his mother. Mrs. Bessie Agnew, Whitefish; three brothers, Austin and Raymond, both of Whitefish and Kenneth of Great Falls; one sister, Sharon Pahrman of Great Falls and several aunts and uncles.

Funeral services for Mr. Pahrman are tentatively being planned for Wednesday afternoon in the Austin Chapel with interment to be in the Whitefish Cemetery.

Bigfork Man Killed In Explosion 18 may 1970

GREAT FALLS (AP) - An explosion in a Great Falls home has taken the life of a young man from the Flathead area.

Authorities identified the victim as Robin Podbielski about 20, of Bigfork.

Officers said he died when what was believed to be experimental rocket fuel exploded Tuesday afternoon in the Clarence Wright home. Podbielski and Robert Wright, 21, reportedly were mixing the fuel in the basement of the home when the blast ripped through the build-

Wright was hospitalized with minor injuries, officers said. Also killed in the explosion was the Wright's pet dog.

Officers said Steve Wright, 17, was in another room when the blast occurred and he escaped injury.

·LIBBY - Members of the David Thompson Search and Rescue Assn, found the body of Joe Pondelick. Libby. Tuesday afternoon. His pickup truck was spotted west of the Cabinet View Golf Club where he had apparently been stricken and died.

Funeral services will be at 10 a.m. Saturday with Rev. William W. Hawthorne of the First United Methodist Church officiating with interment in the Libby Cemetery.

Pondelick had been under a doctor's care for treatment of a heart ailment. He was first reported missing from his home about 8:30 a.m. Monday, Search for him was continued through the day. Tuesday Sheriff John Fisher ordered two aircraft into the air and the vehicle was spotted from one of the flights. The ground crew moved in under radio instruction from the 11 circling plane.

He is survived by his wife at the family home and a daughter Gave. who was Libby's 1970 Junior Miss and valedictorian of the Libby High School graduat-

ing class.

He is also survived by two other daughters, Mrs. Carmen Hench, San Jose, Calif.; Mrs. Teree Myhraug, Shreveport, La., and four sisters, all residing in Libby.

Wilson said searchers will continue to check possible sightings and new leads. "However, at this point we have no new leads." he reported. "It's like the proverbial needle in a haystack."

Today's search will again be concentrated northward with headquarters at Glacier Park International Airport. Wilson said planes will not go into Canada but both the North Fork of the Flathead River and the Hungry Horse Reservoir area will be flown. Pilots will also recheck the Mission and South Fork.

Potter was reported overdue on his flight to Kalispell after he failed to close out his FAA flight plan Sunday night. Speculation is that he may have fallen asleep and either crashed into a mountain or run out of fuel and crashed.
