**Autopsy Called
In Death Of
Infant Boy**

Flathead County Coroner-Sheriff Ross Wilson has called for an autopsy to determine the cause of death of a 2½ months old baby, Jerry Ray Treat, son of Mr. and Mrs. Howard Treat, 72 Third Ave. W. N.

The Kalispell ambulance was called at 12:30 a.m. Saturday when the parents found the child lying on his stomach in his crib and apparently dead. The death was confirmed on arrival at the Kalispell General Hospital and the coroner's office was contacted.

Wilson said the death is apparently one of natural causes with the autopsy ordered to make confirmation. The baby's body was taken to the Van Leuven Funeral Home, Columbia Falls, where service arrangements are to be made.

The infant was born April 28, 1970, in Whitefish.

He is survived by his parents; a brother, Ronald; grandparents, Mr. and Mrs. Howard V. Treat, Kila, and Mrs. Celia Knopp, Kalispell; and his great-grandparents, Mr. and Mrs. William Jordon, Exelland, Wis.

Roy Stephen Trent was born July 16, 1918 at Devon, Montana, a son of Chauncey and Anna Trent. He moved with his parents to Whitefish in 1919, where he attended school graduating with the Whitefish high school class of 1937. While he was in high school he was employed by the Knott Mercantile Company, where he continued to work after graduation and learned the trade of tinsmith as well as furnace and heating business.

At the time of World War II he was in the National Guard and with many others in this Whitefish unit was transferred into the U. S. Army. Upon his honorable discharge he returned to Whitefish where he continued with the Knott Mercantile Company and with the exception of a few years when he worked in Missoula and several other communities, he remained with Knott Mercantile until the company went out of business in 1955.

In 1958 he opened up his own business on West 2nd street where he at the present time owned and operated the Whitefish Sheet Metal and Heating Shop.

He was married to Dorothy Johnston June 5, 1948 at Whitefish, who now survives him.

He was a member of the Whitefish Lodge No. 64 A. F. & A. M., Royal Arch Masons, Loyal Order of Moose Lodge No. 642, Legion of the Moose and Fellowship Degree of Moose.

Trent died March 20 in Whitefish, at the age of 51 years.
