Robert J. Allen, 19

A two vehicle accident in Missoula late Wednesday night has claimed the life of a Kalispell man.

Robert J. Allen, 19, and a Moorhead, Minn. woman were killed when their small sports car collided with a pickup truck on a Missoula main street.

Allen was the son of Kalispell City Councilman Robert G. Allen. He was stationed at Fort Carson, Colo. and home on leave from the Army at the time of his death.

Ann Marie Larson, 18, a University of Montana freshman, was also killed in the wreck and two other UM students were injured. Susan Kay Barker, 18, Billings and Karla A. Holm, 18, Edina, Minn., were listed in satisfactory condition at a Missoula hospital Thursday night.

According to police reports the accident occurred about 11:45 p.m. Wednesday when Allen lost control of his vehicle on a curve on Orange Street

near Sacajawea Park.

His southbound vehicle went into a broadside skid, crossed the centerline and collided with a northbound pickup driven by a Missoula County sheriff's deputy, Sergei Hoff, on his way to work. Hoff sustained minor injuries and was treated and released at a Missoula hospital.

Police said the Kalispell man was apparently driving at a high rate of speed when he lost control of his car on the icy street.

Authorities did not release the names of the victims until late Thursday afternoon.

A coroner's jury was impaneled Thursday to view the bodies, vehicles and accident scene but no inquest date has been set.

Allen was born Jan. 15, 1959, in LaMesa, Calif. to Robert G. and Fay Allen. He came with his parents to Kalispell in 1969 and graduated from Flathead

High School in 1977. He participated in football, photo club, track, hiking, mountain climbing, hunting and fishing. He enlisted in the U.S. Army in July 1977 and took basic training at Fort Knox, Ky., Air Traffic Control School at Ft. Rucker, Ala., and finally was stationed at Ft. Carson, Colorado with the 4th Aviation Co.

He is survived by his parents; two brothers, Michael, Reno, Nev., and John in Kalispell; two sisters, Elizabeth and Donna Allen both of Kalispell; paternal grandmother Doris M. Allen, Lemon Grove, Calif., and maternal grandmother, Agnes F. Fouhy, Fremont, N.H.
