

She attended Commercial Art School in Seattle, and then began working for Francis Wright, a maker of specialty candy boxes. She designed fancy boxes for various west coast candy makers as well as for Brown & Haley.

Art, particularly water color and oil painting, always was a passion for her. A stickler for detail, she perhaps was best known for her paintings of the several historical ghost towns throughout Montana. With the persistent ravages of time, elements and development, some of her paintings stand among the few records remaining of particular buildings and sites.

When not pursuing her own art interests, she could often be found teaching and encouraging others in their artistic efforts. She taught art privately and publicly at her home and elsewhere such as at Bigfork High School, Flathead Valley Community College and the Village Square Art Cultural Center. As an early member of the Village Square Board of Directors, she was a champion of the founders original vision of a showcase for local artists.

She was a charter member of the Montana Watercolor Society and was among the first exhibitors and continued doing so, for more than a dozen years at the Spokane Museum of Native American Culture Art Show. She especially enjoyed exhibiting each year at the Bigfork P.E.O. Art Show. More than one nationally known western artist considered her to be among the best watercolorists in Montana. It was a cruel twist of fate that a virus quietly evolved into sight-robbing glaucoma, stealing much of her precious vision in recent years.

As passionate as she was about art, she also threw herself into other interests with equal zeal. She was a charter member of the Flathead Valley Sports Car Club in the mid-70s, enjoying tours and rallying in her AH Sprite and F.L.A.T. OSCA

her AH Sprite and F.I.A.T. OSCA.

In the mid 1950s, she helped organize and produce various talent shows and programs at the Swan River Community Club. She always was a strong supporter and enthusiastic participant in home extension clubs

and projects. Perhaps one of her most favorite activities was her involvement in the Puttering Potters Ceramics Club, which still meets regularly after more than 30 years. After creating the club with a handful of eager house and farm wives, she said she always was pleased to see the same inherent talent the women displayed in their cooking and homemaking efforts reflected in their clay and glaze creations.

For some seven years, she was a well-known and anticipated Avon salesman in the Bigfork area, earning several awards for her marketing accomplishments. But she often said making a sale was incidental to simply visiting with and looking in on her "regulars." She was active in the Order of the Eastern Star, serving as worthy matron of the Flathead Lake Chapter No. 128 in Bigfork.

Back in 1941, while still in Seattle, she found herself unwillingly going out on a blind date with an equally reluctant Naval aviation machinist's mate, a handsome, blond cowboy from Montana. She and Don Gross this summer celebrated their 56th wedding anniversary. Immediately following World War II until 1954, the couple operated a cattle ranch between Valier and Dupuyer. Along with her husband, she always enjoyed good horseflesh and as a young girl herself had a five-gaited American saddle horse, Pete, with whom she effectively competed in amateur dressage. The financial restraints of the Depression, however, kept her from serious competition. She had lived in the Swan River area with her husband, Don, and family for 43 years.
