He was preceded in death by his loving wife, Margaret, in November 1990, after 53 years of marriage; his parents; and sister, Josie Clara.



At the time of his death, he was serving as president of the Mountain Bluebird Trails, Inc., and had served as a board director for the North American Bluebird Society. Many recreational hours were spent along his personal trail, stretching from Ronan to the treasured family cabin along the Clark Fork River near St. Regis.

He was a great fan of high school athletics and was active in the Ronan Booster Clubs. He participated in community service organizations and was the recipient of the 1998 Community Service award from the Ronan Area Chamber of Commerce. He was a past master of the Ronan Masonic Lodge #78 and participated in the Scottish Rite and the Shriners. He was also a member of the Polson Elks Lodge.
