

At Richard's request, cremation will take place and the family will hold a private service at a later date.



Stanley Charles Gross, 84, "left this world to join his wife" on Sept. 11, 2003, "Patriot's Day," in Missoula.


He was born to Raymond Gross and Mildred Hicks Gross


ing them.
