He served in the Royal Canadian Air Force after high school as an air frame mechanic, but left to come to the United States as part of a legal intern program. Believe it or not, there was a shortage of lawyers at the time.

He moved his young family to San Diego, Calif., in 1959, where he coincidentally began a lifelong career in title insurance. He moved his family to Kalispell in 1963, when he assumed a position as manager of the Flathead County Title Insurance Company.
