## Clair Francis 'Bud' Gard, 75

On Oct. 5, 2006 a great man, "our beloved" Bud Gard, husband, father, grandfather, and friend left us after a lengthy fight against a variety of illnesses. He was 75 years old. A family man to the end, he died at St. Pete's Hospital holding his son Dan's hand, his family all around him in body and spirit.

"Bud's family believes that it's not right that when someone dies that person's life is 'summarized' by the simplicity of a hyphen - a dash between birth and death dates in an obituary or on a grave stone. That is not good enough for a man like Bud Gard. He was so much more. More than just a 'hyphen' or a 'dash.'"

Bud lived a full life; he was born in Grand Island, Neb., on Nov. 17, 1930, delivered by Dr. Woodroff in the family home. Coincidentally, Dr. Woodroff also delivered his wife to be, Belle.

Bud grew up on a turkey farm (which is why he hated turkey at Thanksgiving) with his two sisters and later left the farm to join the U.S. Navy. During his time in the Navy, he served onboard the USS Roosevelt and became a veteran of the Korean War. In another of life's coincidences, in 1974 his son Tim later served onboard the USS Midway, the sister ship to the USS Roosevelt.

After serving two years as a fire control technician, he had to take a hardship discharge from the Navy to run the family farm when his father contracted polio. He returned home, hired a farm manager and got the farm affairs in order. He later left the farm and joined the Air Force in 1950.

Initially assigned as a military policeman in post World War One (the big one) in Okinawa he began corresponding with his childhood sweetheart Belle Reynolds, and they were soon married in 1951 in Condon, Ore. They later had three boys, Dan, Tim and Robbin.

His work in the Air Force was to facilitate the installation of early warning missile systems in all our Northern states. As each base was completed he moved his family to the next base project every few years traveling from Cheyenne, Wyo., to Anchorage, Alaska, to Colorado Springs, Colo., to Lakeside, as he worked to keep our country safe.



Always an avid fisherman, he and his family enjoyed some of the best years of their lives together fishing on the Kenai Peninsula or trolling for bull trout on Flathead Lake.

As a first sergeant in the Air Force, he shaped many young airmen's lives on these remote bases as he shared his wisdom and values with them. He served a tour in Vietnam and retired from the Air Force after 20 years of service.

Joining the civilian work force, he then took a variety of jobs, primarily in warehousing

with Bell Manufacturing, Baier Manufacturing, and with the oil pipeline in Alaska and in Saudi Arabia for seven years with Northrop. During this time, he and his wife toured the world and shared love, laughter and great times. They eventually returned to Montana, and he retired for the second time from the Environmental Protection Agency in Helena, after triple bypass surgery.

Bud was famous for his honesty, always speaking his mind, and his very dry sense of humor. After he retired he loved to watch "Cops," "The Weather Channel" and "CNN." He also liked to listen to country and western music, but not new wave or rap. He liked the singers Patsy Cline and Marty Robbins. He loved Orange Julius drinks at the mall, loved the rain and loved his yard. He disliked PETA, but loved animals; he loved the forests but was not a tree hugger; he loved his country, but wore out the mute button on his TV remote during the Clinton administration.

He had a tremendous love and respect for Montana, its beauty and wildlife, but his main love was for his family. His favorite hobby was fishing and camping, and he passed on such a love and respect of nature that it led to his oldest son, Dan, becoming a fly-fishing guide. His sense of humor was legendary and inspired his middle son to become a professional speaker and humorist. His youngest son, Robbin, emulated his father by becoming a loving father, husband, and role model for others.

During their time together, the love of his life, Belle, became an accomplished artist and Bud was his wife's greatest patron, encouraging her to attain her art degree and finish college at 55 years of age. Whenever she told him, "I love you," he replied: "I love you more."

Bud is survived by his bride of 55 years, Belle; their three sons, Dan and Jessie, Tim, and Robbin and Callie; four grandchildren, Brian and Johnna, Brandon, Andrew and Morgan; and one great-grandchild, Madisyn. Even during his very difficult last days when he was so sick and unresponsive at the hospital, he would smile and reach for Madisyn whenever she came to visit him. His sister, Marian Charles, lives in Colorado.

He was preceded in death by his parents, Goldie and Clair; his sister, Pat Camblin, and a sister who died in infancy.

A life celebration for Bud will be held at 1 p.m. Oct. 14 at Hagler-Anderson Mortuary, 650 Logan, in Helena. All his friends and family are invited.

## James Raymond Garner, 54

With sadness we announce the death of James Raymond Garner, of heart failure on Oct. 31, 2006, while at home in California on his ship, the Sea Wave. An accomplished and versatile musician, he was also at various times an organ-builder, sea captain and computer retailer.

He was born Dec. 5, 1951, in Santa Ana, Calif., to Genevieve and James Austin Garner. He majored in organ performance at the University of Redlands in California, and earned the Bachelor of Music degree in 1974. Following graduation, he established an organ building, restoration and maintenance firm, Raymond Garner & Co. He was responsible for the construction and preservation of nine or more instruments, including a handheld portativ organ for the National Cathedral in Washington, D.C. Ray's "magnum opus" was the restoration of a three-manual Levi U. Stuart mechanical action organ, which he resurrected from a Masonic hall in Sydney, Ohio, and placed in St. John's Episcopal Church in San Bernardino, Calif.

In 1982, Ray and his wife Shauneen moved to Kalispell, following his installation of two restored organs in Flathead Valley churches. He was an active musical force in Northwest Montana. Ray and Shauneen were founding members of the Glacier Symphony and Chorale, together with Doug and Lindy James and Becky and Frank DuBois. In the early years of the GSC, Ray could be found variously playing bassoon, tuba, percussion, singing tenor or conducting. He was also a Dixieland jazz musician, and performed in many jazz festivals throughout the West. Locally he played both piano and sousaphone in several ensembles, including the Flathead Valley Community Band and the Rocky Mountain Rhythm

Kings. In 1993 he and Karla West co-founded the Glacier Jazz Stampede, a festival which continues to attract dozens of Dixieland groups and hundred of fans from across the country each year. Ray was a virtuosic ragtime pianist, and specialized in the repertoire of Jellyroll Morton. During his years in Montana, Ray also owned Montana MicroSystems, a computer consulting firm.

In 1994 Ray moved to Denver to take the position of organist at the First Church of Christ, Scientist. He later also held the post of Associate Director of Music at the Cathedral of the Immaculate Conception, Denver.

In 2000 Ray moved to California and became the Assistant Director of Music at St. Mary's Cathedral in San Francisco. His final post was Music Director at St. Perpetua Church in Lafayette, Calif. He was a third-degree member of the Knights of Columbus.

Early in 2006 he determined to purchase the historic tug-boat "Sea Wave," berthed in Seattle. After arduous labor, he sailed it to Point Richmond, Calif., where it is now docked. While in Seattle, he was spotted by a television production company, which led to his (and Sea Wave's) appearance in a Chevrolet commercial. At this point he became a member of the Screen Actor's Guild.

Mr. Garner was a vibrant, entertaining performer who could always captivate any audience. He is survived by his mother, Genevieve; wife, Patrice; former wife, Shauneen; and children, Sidney, 27, Adrienne, 22, and Morgan, 17.

A Mass of Resurrections was held Nov. 11 at St. Perpetua Church in Lafayette, Calif. A memorial performance of Mozart's "Requiem" will be held in California in spring 2007, conducted by Shauneen Garner.

There he worked at Consolidated Shipyards during the day and attended classes at Dewey Technical Institute at night.

In 1943 he entered the U.S. Army Air Force. After teaching advanced electronics for two years at Truax Field in Madison, Wis., he was assigned to "Project B," a highly classified special instruction program for all B-29 bomber radiomen. Among those he taught were the radio operators who flew the historic missions in the Enola Gay, dropping the first atomic bomb in Hiroshima, Japan.

While at Madison, Tom met and married Stella Ruth "Peggy" House of Jasper, Ala., on Jan. 24, 1945.

Following service in USAAF, Mr. Glanville continued his college education at USC and UCLA, majoring in mathematics and electrical engineering.

In 1948, Tom began a career with Northrop Aircraft of Hawthorne, Calif., which spanned a total of 45 years until his retirement in 1993. Early in this employment, he participated in field test work as an engineer on the Snark missile project (first intercontinental missile) at Holloman Air Force Base in Alamogordo, N.M., and the Long Range Proving Ground at Cape Canaveral, Fla. At the Florida facility, he supervised the installation and operation of all the telemetry ground stations from Grand Bahamas to Ascension Island.

Following field test, Tom was recalled to the home offices in California where he rose rapidly in management, and by 1956 became general supervisor of Missile and Aircraft Instrumentation, directing the efforts of over 200 engineers and technicians. During his employment as an engineer, he was responsible for many innovative electronic circuitries, including special components for the first known analog-digital computer (MADIDA) which was later purchased by the National Cash Register Co. Other notable inventions include a sensitive micro-farad capacitor measuring system, an electronic commutator for radio-telemetry systems, and the first known tube aging device for specialized D.C. amplifiers.

Mr. Glanville retired from Northrop after 30 years and formed his own Electronics Consulting Company of which he

was president. A few months later he was recalled to Northrop as a consultant on the B-2 Bomber program. He remained as a consultant on this program until his retirement in 1993.

Some of the highlights in Mr. Glanville's life included: meeting General Jimmy Doolittle; discussing space programs with Carl Sagan; business meeting with General Omar Bradley, the president of Bulova; and a personal chat with Charles Lindberg. Tom and wife, Peggy, were also special invited guests at a dinner at Mike Lyman's in Hollywood with Meredith Wilson, George Burns and Gracie Allen, Frank Morgan and Fannie Brice.

Mr. Glanville was very active in youth groups, as a manager in Little League baseball; and president of the Rolling Hills, California, Pop Warner Football Association.

He was an avid golfer and long time member of the Whitefish Lake Golf Club, and boasted two holes-in-one on that course.

Other hobbies included competitive chess, jazz clarinet, duplicate tournament bridge, flying, tennis, table tennis, and amateur radio. In addition to his pilots license, he also held a first class radiotelephone commercial license, and came in second at the tournament at Lincoln Park Chess Club in Long Beach.

In tennis, Tom captained his college team which went undefeated during his tenure. In table tennis he won city and state tournaments in Iowa in both singles and doubles. He also held a Masters Card in bridge. In amateur radio he gained distinction for placing first nationally in mobile radio field day exercises in emergency communications. He was a member of a four-man rifle team which won the National High School shooting championship in 1940.

Among personal honors, Tom received a commendation from Werner Van Braun for activities in the field of guided missiles; a commendation from the CIA for top secret work in deciphering coded Russian missile data; and was listed for many years in "Who's Who in Electronics." He was also a charter member of the Cape Canaveral Pioneer Club.
