Gene was known for his beautiful carpentry work. He had built two family homes, a cabin, added on to another and remodeled many houses. The family will always treasure their memories of the times spent at the family cabin on Echo Lake.

He had been a member of the Montana Landlords Association for more than 35 years and was past state president and current president of the Flathead chapter, and was still active managing his rental properties in the Flathead Valley.

Ever since his 50th class reunion, Gene had enjoyed meeting monthly for lunch with his former classmates.

Gene was also active in



the community with the Flathead County Sheriff's Posse, the Roundup for Safety Commit-

tee for Flathead Electric, Evergreen Lions Club, Elks Lodge and Back Country Horsemen of the Flathead. He was also a lifetime member of Bethlehem Lutheran Church.

# Former fire marshal dies at 81

Eugene "Gene" Thompson, who served as the Kalispell fire marshal during a string of downtown fires during the 1970s that caused millions of dollars in damage and was a recent state president of the Montana Landlords Association, died Sunday at age 81.

"He worked hard and his body was worn out," his daughter Linda Smith said. "He went peacefully in his sleep in the early-morning hours of Sunday surrounded by his family."

Thompson was still actively managing 16 rental properties in the Flathead Valley at age 80, and often found himself traveling the state as part of his duties with the landlords association.

He was a longtime leader in the firefighting community, both locally and throughout the state, after starting with the fire department in Kalispell at age 25. He was off the crew for a while after securing his first job, when the city was forced to cut a position, but he stayed busy with two grocery store jobs and then in 1962 resumed his position on the Kalispell Fire Department.

He ended up retiring as a captain in 1983 after 27 years of service, and he investigated fires and fire-related deaths within a 100-mile radius of the Flathead Valley as deputy state fire marshal for 10 years before leaving that post in 1973.

He also had built his family a home, took on remodeling projects, and acquired houses, remodeled and rented them while holding down his firefighting position.

## Thomas 'Tom' Thompson, 53

Tom Thompson passed peacefully after a 10-and-a-half year-battle with cancer on Friday, Aug. 23, 2013, in Burién, Wash., at home with his loving wife by his side.

He was born on June 23, 1960, in Glasgow to Larry and Ann Thompson, joining brother Jerry. In 1962 they moved to Kalispell, where in 1964 sister Mary joined the family. He went to school at Elrod Elementary, then to Linderman, then on to Flathead High. Half brother Chris joined the family in 1973.

He then moved to Everett, Wash., in 1978, and went to work at Spencer aircraft, where he worked until one week before his death.

He met the love of his life, Debbie LaMar, in 1979. They were married on March 14, 1981. Of this union came one daughter, Brandie LaMar Thompson, on April 5, 1984.

Tommy's greatest passions were fishing and beachcombing. He also enjoyed going to or watching Husky or Seahawk football. Tommy lived life to the fullest. He was the clown of the family. He always thought of others first.

He set goals for his



fight with cancer. He traveled to England or went to the beaches. His final two goals were to see

his precious granddaughter, Penelope Elizabeth "Penny" Carlson, born on May 30, 2013, and walk around the point in Oceanside, Ore., with his wife Debbie.

Tom was preceded in death by his father Larry Thompson, and his brother Chris Thompson.

He is survived by wife, Debbie; daughter, Brandie, and Pete Carlson; granddaughter, Penny; brother, Jerry, and Misty Thompson; sister, Mary, and Patrick Booth; mother, Ann Bell; step-mother, Margaret, and Bill Miller; and numerous nieces and nephews, aunts, uncles and cousins who will miss his greatly.

A celebration of life is scheduled for 4 p.m. Saturday, Aug. 31, at his sister's home, 732 Willow Glen Dr. Potluck and BYOB.

As his daughter said, "He came, he saw, he fished!"
