### Paul L. Daly, 93

He died of natural causes on Dec. 28, 2014, while returning home to Columbia Falls from his winter residence in Green Valley, Arizona. The intervening years were lived to the fullest, reflecting Paul's courage, energy and wide-ranging interests, his hard work and entrepreneurial spirit, and his deep commitment to family and friends.

While growing up, he lived and attended school in Missoula, but summers and any other possible opportunities were spent in the Grasshopper Valley of Beaverhead County, on the Marchesseau family cattle ranch homesteaded by his mother's parents. There he learned the values of hard work and good land stewardship, and became determined to have his own ranch one day.

Paul graduated from Missoula County High School just as Congress enacted the Civilian Pilot Training Act of 1939. He enrolled and received his early flight training from Johnson Flying Service at Hale Field in Missoula, while also pursuing a degree in wildlife technology at the University of Montana (then called Montana State University).

When the U.S. entered World War II, Paul enlisted in the U.S. Navy, and was sent to Norman, Oklahoma, and later Corpus Christi, Texas, for aviation cadet training. Commissioned as an ensign in 1943, his initial assignment was to Squadron VF-15 on the aircraft carrier USS Essex, preparing for combat in the new F6F Hellcat fighters. There he, at one time, flew wingman for Commander David McCampbell, later the Navy's top ace in World War II.

ing nis divorce, Paul sold his share in Executive Air and moved to Spokane, where he established a new business at Spokane International Airport, eventually building it into one of the largest FBOs in the Inland Northwest.

When he married Carol King in 1969, they purchased a small ranch near Whitefish, the first of several they would own. Selling both Executive Air and the Whitefish ranch several years later, they purchased a larger ranch in the Blackfoot Valley and Paul, using the skills and knowledge gleaned from years of working on his family's ranches, began to build his own herd. As a small operator, he needed to be both efficient and cost-effective, which led to his installation of the first pivot irrigation system in the area, the use of artificial insemination, and an afternoon feeding schedule which resulted in more calves being born during daylight hours.

In 1981, Paul was officially retired from the U.S. Navy, and two years later he decided to retire completely. Selling the Ovando ranch, he moved to Bigfork, where he planned to play golf and learn to sail. Soon, however, he was approached about an opportunity to invest in a small Kalispell precision machining firm which had just received a large defense-related contract. He couldn't resist the challenge, which led to another decade of hard work, during which JBM Inc. also became a prime contractor for Boeing and was named E-Systems' 1985 Subcontractor of the Year.

upon qualification as combat ready in February 1944, Paul was assigned to Squadron VF-44 and the carrier USS Langley, from which he participated in numerous bomber support and strike missions during the Battle of the Philippine Sea and the Battle of Leyte Gulf, among others, and was subsequently awarded the Air Medal "for meritorious achievement while participating in aerial flight."

Released from active duty in 1946, Paul considered becoming a commercial airline pilot, but chose to return to UM, earning a Bachelor of Arts degree in business administration in 1947. He and his best friend started a business supplying records for jukeboxes in restaurants and bars in the Butte area, but in 1948 Paul was recalled to active service for the Korean War. He was sent first to Dallas for refresher training, and then on to Pensacola, Florida, as a flight instructor for new aviation cadets. In 1953, he qualified in the UF-1 Albatross and was sent to Argentia, Newfoundland, where scouting and observation flights over the North Atlantic were conducted to detect any potential threat from the Soviet Union.

In 1954, Paul returned to Missoula, where he and his wife Totsye raised their children, and Paul started a used furniture and, later, upholstery business. Continuing his service in the U.S. Naval Reserve, Paul also branched out into civilian

Finally, in 1992, real retirement became possible. Spending his winters in Arizona and summers in Montana, Paul was able to enjoy years of golf, fishing, dancing and the good company of friends (old and new) and relatives.

Paul was preceded in death by his parents; his sister, Bette Overby; and his daughters, Joan and Janette Daly.

Wednesday, Feb. 25, 2015. George was born in Osage, Wyoming, to George W. and Marjorie Ord Darrow, on Friday, Aug. 13, 1924. The family moved to Lewistown for a short time following the bil fields, then to Rochester, New York, where he attended high school. The family spent many summers traveling back and forth to the family ranch in Lusk, Wyoming. The Ord Ranch remained in the family for over 100 years, and was a venue for many enjoyable annual family get-togethers.

George attended the University of Michigan, first receiving a degree in economics. He played football and was on the wrestling team there.

After graduating, he worked a short time for an export company, but determined that an indoor job was not for him and took a job as a rough neck in the oil field close to the family ranch in Wyoming. Gaining an interest in the oil field industry, he returned to UM to major in geology. During this time, he received officer's training as an ROTC and enlisted in the Navy as an officer during World War II. In fact, he had completed specialized radar training and was preparing to ship out on a destroyer from port in San Diego when the bomb was dropped on Hiroshima in 1945, effectively ending World War II. After his honorable discharge, he returned to UM to complete his geology degree.

His first geology job was with Amerada Hess, in Casper, Wyoming, later transferring to Billings. After a few years, he became an independent

geologist. In 1953, George married Eileen Riedl, at the Crossbow Ranch, a dude ranch that they jointly operated during summers in the Beartooth Mountains, near Yellowstone National Park. To this marriage

din farms in Bigfork, in 1976. George and Elna enjoyed 32 years together before she passed away in 2009. As a Bigfork resident, George was involved in diverse business ventures. # 'Pillar of Biqfork' dies at 90

# Darrow shepherded lasting environmental laws

Longtime Bigfork civic lead er and environmental policy pioneer George Darrow died Wednesday in Kalispell. He Darrow and his wife, Elna, who died in 2009, were consummate volunteers for decades in the Bigfork community where they owned and operated Kootenai Galleries for many years. He was a driving force behind the Bigfork Center for the Performing Arts and led an effort to raise nearly \$1 million for

the center in the mid-1980s.
"He was a pillar of Bigfork," said Bruce Solberg, former Bigfork Chamber of Commerce director. "He was always an influential guiding force, there to lend an ear and give really good advice."

Bigfork attorney Randy Snyder recalled how the Darrows "gave sacrificially of their time.

"He and Elna were a constant, visible face and voice of

support for this community,"

always spoke his mind about the topic at hand. "He was a really determined

"He was a really determined man and strong in his beliefs," Solberg said. "If he had an opinion he would definitely share it."
Sen. Bob Keenan, R-Bigfork, said Darrow was "uncompromisingly passionate" about his promotion of Bigfork as a

conservationist and wilderness advocate.
As a state legislator, Darrow

was equally passionate about

Montana and his work as a

destination resort village. He

in 1971 wrote and led the passage of the Montana Environmental Policy Act, landmark legislation that still guides the planning of development projects with a focus on environmental impacts.

Darrow served as a Republican lawmaker representing Yellowstone County in both the Montana House and Senate from 1967 to 1974. Right out the chute as a new legislator, Darrow was the chief sponsor of the Montana Water Policy Act in the 1967 Legislature. He remained a vocal advocate for clean water.

As an elected legislator in 1972, Darrow couldn't participate in Montana's Constitutional Convention as one of its 100 citizen delegates, but he followed the process intently, Swan View Coalition Chairman Keith Hammer noted in a 2012 article he wrote about Darrow in the Conserve Montana publication.

Hammer recalled how Darrow gave him a copy of the Montana Constitution with certain phrases highlighted such as this one: "All persons are born free and have certain inalienable rights. They include the right to a clean and healthful environment ... In enjoying these rights, all persons recognize the corresponding responsibilities."

The Darrows were active in the Bigfork

Chamber of Commerce when Hammer first became active in trying to protect the Swan Range and secure a wilderness designation for the Swan Crest. He noted how the Darrows persuaded the Chamber to support the wilderness proposal.

"George has been at the cutting edge in arguing for preservation of the incalculable value pristine forests and waters contribute to local economies," Hammer said.

In 1992 Darrow testified before a U.S. House Agriculture Subcommittee, telling federal lawmakers: "One of the sustaining attributes of the Bigfork area and indeed, the other forest inter-linked communities of the Flathead Valley, are the ramparts of the Swan Range rising 4,000 feet above the valley floor within the Flathead National Forest. The entire snow-capped Swan Crest from Columbia Mountain through the Jewel Basin and into the **Bob Marshall Wilderness** provides the high-quality watershed, recreation and wildlife habitat that underlie the Flathead economy."

Darrow came by his interest in the natural world through his farming and geology backgrounds. He was born in Osage, Wyoming, at the time an oil-field boom town 60 miles south of the Montana border. His father, following another

oil boom, led the family to Lewistown a few years later.

He earned degrees in geology and economics from the University of Michigan, serving in the Navy between his two courses of study. He worked for several companies in oil and groundwater exploration after moving to Billings in 1949 and was a consultant until moving to the Flathead Valley in 1976, the same year he and Elna were married.

The Darrows operated an extensive farm operation on two sites in the Bigfork area, growing grain and hay and raising livestock. They restored an old homestead near Bigfork, with an 1894 cabin serving as Darrow's office.

She could hardly wait to become a grandma ar 1 she enjoyed and loved them all deeply.

Corky had a kind heart and was known for bringing soup and pie to sick friends and grieving families. She could be counted on when people needed her most thing that friends have been conveying to our family for some time now. She cared for her grandmother, mother and uncle in their declining years and was a dedicated and loving daughter, granddaughter. niece, wife, mother and friend.

### Montana author Ivan Doig dies at 75

SEATTLE (AP) — Ivan Doig, an award-winning author whose books set in his native Montana made him one of the most respected writers of the American West, has died. He was 75.

Geoff Kloske, the publisher of Riverhead Books, said in a statement that Doig died Thursday of multiple myeloma at his Seattle home.

"Ivan was one of the greats," Kloske said. "We have lost a friend, a beloved author, a national treasure."

Doig was born in 1939 in White Sulphur Springs, Montana. The former ranch hand earned bachelor's and master's degrees in journalism from Northwestern University and a Ph.D. in history from the University of Washington.

He wrote 16 books, including the so-called McCaskill trilogy, three novels about a fictional Montana family covering the first 100 years of state history. His 1979 memoir, "This House of Sky," was a finalist for the National Book Award.

In 2007, Doig won the Wallace Stegner Award, which recognizes someone who has "made a sustained contribution to the cultural identity of the West." He was also the recipient of the Western Literature Association's lifetime Distinguished Achievement award.

His publisher said that two of Doig's later works, "The Bartenders Tale," released in 2012, and the yet-to-be published "Last Bus to Wisdom," were inspired by experiences from Doig's youth. But the author also made it clear that his novels were fiction.

His writing gained him many admirers. The Aus-

tralian author Thomas Keneally said Doig was "one of the great American voices, full of grace, abounding in humanity, easeful in narration, hypnotic in pace, grand in range."
