Tony and Willie remained in Seattle that day and have lived since in Federal Way, Washington, among family in the Puget Sound region.

Following the accident, Willie saw and enjoyed many wonderful events including the growth of her 10 grandchildren. She became an ardent supporter of the Seattle Mariners and Seattle Seahawks. She also contributed to and participated in the local Catholic parish of St. Theresa's.

Willie's greatest love was for her family, her husband, children, grandchildren and extended family. She could recite birth dates of all 60 plus of her nieces and nephews. She was a hub of communications for not only her immediate family but hundreds of friends and relatives all around the world. Her handwriting was firm and unmistakable. # 2 dead in house fire

# House a complete loss on Trumble Creek Road

An intense house fire that destroyed a home on Trumble Creek Road has left two people dead.

Flathead County Sheriff Chuck Curry verified late Monday that an adult woman and a 3-year-old boy died in the blaze.

Officials will not release the identities of the deceased until family members have been notified.

The fire broke out shortly after 9 a.m. Monday morning. By the time firefighters arrived, it was completely consumed in flames.

"There was fire coming out of all four walls, all three floors," said Columbia Falls Fire Chief Rick Hagen.

Two people escaped from the house, which had two stories and a basement. One left from the top floor while the other made it out of the basement.

But another two people were unaccounted for by the time firefighters got control of the blaze. They were trapped in the basement level.

Hagen said at midday that the likelihood of people surviving in those conditions for a long time is zero. An excavator was brought in to remove debris so investigators could examine the structure.

Authorities recovered the bodies Monday afternoon.

Curry was on the scene as coroner.

After the fire, the home had almost completely collapsed into its footprint. Only small pieces of concrete walls remained standing.

Columbia Falls, Whitefish, Bad Rock, West Valley and

Evergreen fire departments responded to the scene. Personnel from the Montana Department of Natural Resources and Conservation also responded.

Hagen said there wasn't an initial determination into the cause or point of origin, but the investigation is ongoing.

"How that fire can get so big so fast is one of the things

we've got to find out," he said.

# Officials identify fire victims

Officials have released the names of a mother and her child who died in a house fire Monday.

Brittany Kayleen Ince, 30, and her son, Gavin Thomas Henrichon, 3, were trapped in the basement as fire consumed the home on Trumble Creek Road, south of Whitefish.

Flathead County Sheriff Chuck Curry identified the victims on Tuesday.

Officials knew early on that two occupants were unaccounted for. It took hours of excavating the debris before the bodies were recovered.

The fire started shortly after 9 a.m. Monday and quickly filled the two-story home. Two people escaped from the basement and second floor.

According to a crowd-funding site that was set up to help the family, Gene Hallas awoke to the smoke and was forced to jump from the second-floor window.

The cause of the fire is still under investigation, according to Columbia Falls Fire Chief Rick Hagen. An interagency investigation team will investigate the incident.
