

Duram said they believe that man's driving did not cause the crash, however. A third, unrelated ATV rider also could face a driving under the influence citation.

Ronald Loyd Martin, 65

Ronald Loyd Martin, 65, born on Oct. 18, 1948, passed away late in the evening on June 14, 2015, after a courageous battle with gastric cancer.

Ron grew up in Swan Lake, and remembered, at a mere four years of age, seeing his first big yellow pine while riding in the back of his parents' 1948 Ford. He knew from that moment that he would spend his life working in the timber industry, first as a logger and later as an essential forestry planner, focusing on sustainable timber practices, fire protection, and fire preservation.

Ron attended Bigfork High School where he was a sports enthusiast, and later attended Montana State University and the University of Montana. In 1969, Ron began his long career in the timber industry with the Duwamish Sea Board Lumber Company. From there, Ron's love of the forest led him to a job with the Weyerhaeuser Company, where he learned every aspect of timber management, from how to run the equipment to falling the last of the true old growth in Washington. On December 4th of 1970, Ron took his first cutting job at Nine Mile, west of Missoula. His success falling trees in extreme conditions led him to Kake, Alaska, where he fell timber with the likes of characters named Everclear Mike, Bullshit Bobby Thompson, Earl the Squirrel, and Ken the One-Eyed Explorer. After Alaska, Ron went to work as a jippo logger for various Montana logging companies.

In 1973, Ron fell in love with Bitterroot Lake and decided it would be the place he would call home. In 1983, Ron worked on Mt. Saint Helen's during the second eruption and moved to Buckley, Washington, in 1987 to fall big timber. In 1991, Ron returned to Bitterroot family.



Lake and later founded Martin's Woodlot Services. As a respected timber advocate.

Ron was routinely called upon by the Forest Service to perform work and to provide opinions on forest planning, preservation, and best forest practices.

Ron will be remembered as an eternal optimist, one of the best timber fallers in the industry, an avid fisherman, hunter, and gardener, a father, a brother, a son, and a friend.

Bruce was also an avid volunteer. This included acting as Flathead Democratic precinct person and county chairman from 1994 to 1995 and serving on the boards of Flathead Wildlife and the Flathead Chapter of the Montana Wilderness Association. He wrote numerous letters to the editor on topics from wilderness and timber harvest to human rights.

Bruce loved wild Montana and defended it. In 1977 and 1978, Bruce was subpoenaed to testify on behalf of fish in Federal District Court in Butte.


