During the next 15 years, he was deeply involved in the hospital industry, serving as Board Chairman for the Kalispell Hospital, the new Kalispell Regional Hospital, Chairman of the Board of Blue Cross of Montana, Montana representative to, and Chairman of, the American Hospital Association's National Council of Hospital

Governing Boards, and a member of the AHA's General Council.

Dean retired from active law practice in 1993. In retirement, he has been active in Republican politics, as an editorial commentator for the university's NPR radio station KUFM. Dean loved being outdoors and in addition to hunting, sailing, and fishing he was most of all an avid skier, and a dedicated member of the Over the Hill Gang hiking group in Glacier National Park. Dean enjoyed both international and domestic travel, visiting several foreign countries and most of the U.S. States.

He served as treasurer for the local Republican party for 12 years and was particularly proud of the fact that the party made a clean sweep of the elections in Flathead County for five successive elections. He was the first president of the Flathead County Pachyderm Club. For many years, he assist-
