CORONER TO HOLD INQUEST AT POLSON

Coroner W. J. Miller and Sheriff W. R. Martin went to Polson this morning for the purpose of holding an inquest in connection with the death of Chester Powell, who was killed by a posse in his hiding place in the hills late Tuesday afternoon. Miss Mable Morrison accompanied the officers to act as stenographer at the inquest.

Photographs of Powell's "nest," taken by a Polson photographer the morning after the shooting, were received at the Sheriff's office today. Members of the posse and others posed for the picture showing the position of Powell and the officers at the time of the shooting. An immense pine log formed the protection for the little camp and the place was cleverly concealed by brush. Another picture shows the camp itself and the pile of plunder of various sorts which Powell mentioned in his letter to Hester Powell. The fugitive had a lantern and a plentiful supply of food was in evidence. A bucket of hotcake batter with mixing spoon sticking out and a can of Criscoe nearby indicated one item of his diet.
